Robert Harley, 1st Earl of Oxford was a prominent politician, statesman and patron of the arts. As a preservationist, he was invaluable and used his wealth and power to collect an unparalleled library. Notably he promoted the careers of Jonathan Swift, Alexander Pope, and John Gay.





The Building has been lovingly refurbished throughout, in keeping with its heritage and making best use of the abundant period features. It is entered via an impressive upgraded reception hall which leads to spacious, high-ceilinged office accommodation benefitting from excellent natural light.
